Subject: Request for investigation regarding circulation of unsolicited and misleading messages about the Company

Respected Sir,

We write to bring to your attention a serious matter concerning the circulation of false, misleading, and unauthorized messages relating to our Company on social media platforms and through SMS.

We have received an email from BSE Limited dated 29th April, 2026, informing us that certain claims regarding our Company are being circulated on platforms such as Telegram and through SMS. The claims include, inter alia:

- Execution of an MOU with the Government of Gujarat for setting up a solar project;
- Evaluation of a green hydrogen project;
- Plans for a large project in Africa;
- Statements suggesting that FIIs are holding the Company's stock.

In this regard, we would like to categorically state that we have no knowledge of most of the aforementioned claims. The Company has neither authorized, approved, nor promoted any such stock recommendations, investment advice, or messages. We do not have any association with any individual or entity disseminating such information in respect of the Company's securities.

We strongly deny and condemn the circulation of such false, misleading, and baseless information. These actions appear to be aimed at misleading investors and tarnishing the reputation of the Company. The Company does not support or promote any such activities in any manner whatsoever.


We request your good office to kindly investigate this matter at the earliest, as certain unidentified persons/entities are spreading such rumours and unauthorized recommendations concerning the Company's shares.

We would also like to inform you that a similar complaint had been filed earlier on 13th January, 2026. It appears that certain persons are repeatedly attempting to harm the image and reputation of the Company through such activities.

We request you to take appropriate action against the persons involved and help prevent further dissemination of such misleading information.

Dear Sir / Madam,

This is with reference to the trail mail, wherein you have submitted the police complaint, Company website post and Corporate announcement pertaining to our earlier communication dated January 12, 2026 related to the misleading Social Media Posts related to your company.

With reference our communication in the trailing email, you are requested to take the following actions once again.

1. Lodging complaint against the originator of such research report & circulation of messages on telegram/ SMS by lodging a FIR with appropriate Law Enforcement Agencies viz. Police, Cyber Crime Cell, EOW, etc.
2. Post on Company website providing details of action taken by the company (including lodging of the complaint with the Law Enforcement Agencies) and also mentioning that company, its promoter, promoter group and directors are not involved in the activity of circulation of such videos containing stock tip or recommendation.

Please let us know the steps initiated by you w.r.t. the above (points 1 and 2) and provide us the relevant scanned copies.
